## The Foundation is focused on the future.

When Nancy Davis became the Executive Director for the Hancock Regional Hospital Foundation two years ago, she had some pretty large tasks in front of her. With a staff of two, which she likes to call "small but mighty," and 85 volunteers, the foundation was armed and ready.

In the past year, she led the Foundation to some incredible accomplishments. A record number of people attended the annual Women Helping Women event, and the most money ever was raised for the nursing scholarship with the 36th Annual Golf Benefit.

One of the major goals for the foundation last year was to raise \$100,000 in 100 days for the Rex A. Pasko Hospice Endowment. The Foundation actually raised \$444,000 in 100 days, and has raised nearly \$3 million since the start in 2011.

Currently, the Foundation is busy raising money for the new center for Hancock Cancer Care. \$1,200,000 has been raised so far with the ultimate goal of \$1,500,000 by the end of the year. Nancy says it's no easy task, "For a community our size, that's a pretty big challenge."

The Foundation continues to work hand-in-hand with the community by awarding scholarships, distributing grants to health-related programs, and helping employees through the Associate Crisis Fund. The health care landscape is changing and the Hancock Regional Hospital Foundation will continue to support the advancement of health care and wellness in the communities it serves.

## **Commit To Quit Support Group**

Bill and Nicole Brook were both tobacco users. She smoked and he used chewing tobacco. Nicole had quit twice previously when she was pregnant with her first two children, and while trying for a third child, she finally quit for good.

Bill, on the other hand, continued to chew. Nicole had asked him to quit many times and he would try, but with no success. Then Nicole learned about the Commit to Quit Support Group from Hancock Regional Hospital through her work.

Bill had wanted to quit for some time and immediately felt comfortable in a support group. "It was good to see that I wasn't alone in my fight," he said. Sometimes will power and a support group aren't always enough. The Commit to Quit Support Group also offered a six-month supply of medical aids to help him quit. Bill chose to use Chantix and he was happy to have it, "I needed something to help kick my habit; I couldn't just go cold turkey."

After using chewing tobacco for more than 20 years, Bill is now tobacco-free, but that's not the only habit that's changed. Bill also changed his eating habits and started exercising more, and he has lost 45 pounds. He feels better and is more confident.





# Women Helping Women

On August 20, 2013, Marie Pleak got news that all women fear hearing. She found out she had breast cancer. Marie had received her annual mammogram at the Andis Women's Clinic, which offers services through our Women Helping Women program. As a result of the screening, some dense matter was found in her breast. She then met with Hancock Regional Hospital's Dr. Goedde who biopsied the lump in her right breast, and the tests came back as breast cancer.

After learning her news, Marie saw Dr. Shultz for chemotherapy, and started receiving sessions at the newly reopened cancer center. While there, she was not among strangers. As an ex-hospice nurse, Marie had taken care of two of the cancer center nurses' parents who suffered from Alzheimer's disease. "It was nice to walk in some place and automatically know somebody."

Marie was happy the center for Hancock Cancer Care was where it was and so were her family and friends. "Everybody was glad I went to Hancock, because I was close to home." she said. The close proximity made it easy for her to drive to and from her chemotherapy.

In January, Marie had a lumpectomy, and today she is free and clear of cancer. Marie was very complimentary "of her care: "I received exceptional care when I was at Hancock. It's nice to know the doctors from Indy are coming out here and taking an interest in the hospital. It seems to be growing and changing."





## **Programs**

#### **Traditional Charity Care**

In today's economy, there are numerous individuals who are underinsured or uninsured. They are husbands and wives, neighbors you see at the grocery store, parents with their children at the park. And they deserve and require quality health care. To make sure they get it, Hancock Regional Hospital provides free or reduced care to those individuals and families that qualify.

# Hoosier Healthwise and Healthy Indiana Plan (HIP 2.0)

Hoosier Healthwise (HHW) is the State of Indiana's health care program for children, pregnant women, and families with low income. Based on family income, children up to age 19 may be eligible for coverage. HHW covers medical care like doctor visits, prescription medicine, mental health care, dental care, hospitalizations, surgeries, and family planning at little or no cost to the member or the member's family.

The new Healthy Indiana Plan (or "HIP 2.0") is an affordable health insurance program from the State of Indiana for uninsured adult Hoosiers. The Healthy Indiana Plan pays for medical expenses and provides incentives for members to be more health conscious. The Healthy Indiana Plan provides coverage for qualified low-income Hoosiers, ages 19 to 64, who are interested in participating in a low-cost, consumer-driven health care program. Hoosiers with incomes of up to \$16,436.81 annually for an individual, \$22,246.25 for a couple or \$33,865.13 for a family of four are generally eligible to participate in the Healthy Indiana Plan.

#### **Payment Plans**

Hancock Regional Hospital will work with you to set up a payment plan. For qualifying accounts, the balance may be spread out into 12 monthly payments interest-free. If you need more than one year to pay your bill, arrangements may be made with a low, 12 percent APR interest rate charged. #### Medicare

Hancock Regional Hospital has committed substantial resources to supplement Medicare. Medicare reimbursement continues to lag behind medical industry inflation, placing an increasing burden on hospitals because the reimbursement does not cover the cost of providing services to Medicare recipients.

#### **Subsidized Health Services**

Subsidized health services are services that do not generate sufficient revenue to cover the cost of providing the services, but are offered because of a need in the community. The Knightstown Health Care Center is an example of a subsidized service we offer. Through a grant from the Indiana State Department of Health, the clinic is able to provide quality medical care on a sliding scale for individuals and their families who meet financial guidelines, and who are uninsured, underinsured or who can't afford to pay for an office visit.

#### Jane Pauley Community Health Center

Hancock Regional Hospital has teamed up with the Jane Pauley Community Health Center to open a new reduced-cost clinic in Greenfield, to help make health care obtainable and affordable for Hancock County's underserved individuals. Regardless of insurance or income, patients will have access to integrated medical and behavioral health care along with access to various other social services.

#### **Heartbeats Health Festival**

An annual event for the entire community that provides education, entertainment, and a wide variety of important health screenings at little or no cost. This event is held each year in April at Hancock Regional Hospital.

#### Hancock HealthFest

An annual event where people can meet doctors, ask medical advice and get screenings/tests for free or reduced cost. This event is held in October at the McCordsville facility.

organizations for health-related programs such as nutrition and fitness, tobacco cessation and breast feeding education, just to name a few.

The Women Helping Women program benefits underinsured women in our community. Through donations to the Hancock Regional Hospital Foundation, Women Helping Women provides mammograms, diagnostic screenings and breast-health education.


#### **Hospital Programs**
